THE BUCKLE, INC. REPORTS MAY 2022 NET SALES

KEARNEY, NE -- The Buckle, Inc. (NYSE: BKE) announced today that comparable store net sales, for stores open at least one year, for the 4-week period ended May 28, 2022 increased 5.3 percent from comparable store net sales for the 4-week period ended May 29, 2021. Net sales for the 4-week fiscal month ended May 28, 2022 increased 5.1 percent to \$94.3 million from net sales of \$89.7 million for the prior year 4-week fiscal month ended May 29, 2021.

Comparable store net sales year-to-date for the 17-week period ended May 28, 2022 increased 4.1 percent from comparable store net sales for the 17-week period ended May 29, 2021. Net sales for the 17-week fiscal period ended May 28, 2022 increased 3.7 percent to \$403.4 million compared to net sales of \$388.9 million for the prior year 17-week fiscal period ended May 29, 2021.
