THE BUCKLE, INC. REPORTS JUNE 2019 NET SALES

KEARNEY, NE -- The Buckle, Inc. (NYSE: BKE) announced today that comparable store net sales, for stores open at least one year, for the 5-week period ended July 6, 2019 increased 6.2 percent from comparable store net sales for the 5-week period ended July 7, 2018. Net sales for the 5-week fiscal month ended July 6, 2019 increased 5.5 percent to \$74.8 million from net sales of \$70.9 million for the prior year 5-week fiscal month ended July 7, 2018.

Comparable store net sales year-to-date for the 22-week period ended July 6, 2019 increased 0.4 percent from comparable store net sales for the 22-week period ended July 7, 2018. Net sales for the 22-week fiscal period ended July 6, 2019 decreased 0.1 percent to \$337.6 million from net sales of \$338.0 million for the prior year 22-week fiscal period ended July 7, 2018.
