THE BUCKLE, INC. REPORTS SEPTEMBER 2015 NET SALES

KEARNEY, NE -- The Buckle, Inc. (NYSE: BKE) announced today that comparable store net sales, for stores open at least one year, for the 5-week period ended October 3, 2015 decreased 6.7 percent from comparable store net sales for the 5-week period ended October 4, 2014. Net sales for the 5-week fiscal month ended October 3, 2015 decreased 5.6 percent to \$97.4 million from net sales of \$103.1 million for the prior year 5-week fiscal month ended October 4, 2014.

Comparable store net sales year-to-date for the 35-week period ended October 3, 2015 decreased 2.8 percent from comparable store net sales for the 35-week period ended October 4, 2014. Net sales for the 35-week fiscal period ended October 3, 2015 decreased 1.1 percent to \$706.2 million from net sales of \$714.2 million for the prior year 35-week fiscal period ended October 4, 2014.
