THE BUCKLE, INC. REPORTS NOVEMBER 2017 NET SALES

KEARNEY, NE -- The Buckle, Inc. (NYSE: BKE) announced today that comparable store net sales, for stores open at least one year, for the 4-week period ended November 25, 2017 decreased 3.6 percent in comparison to comparable store net sales for the 4-week period ended November 26, 2016. Net sales for the 4-week fiscal month ended November 25, 2017 decreased 4.0 percent to \$78.3 million compared to net sales of \$81.5 million for the prior year 4-week fiscal month ended November 26, 2016.

Comparable store net sales year-to-date for the 43-week period ended November 25, 2017 decreased 8.3 percent from comparable store net sales for the 43-week period ended November 26, 2016. Net sales for the 43-week fiscal period ended November 25, 2017 decreased 8.5 percent to \$710.5 million from net sales of \$776.5 million for the prior year 43-week fiscal period ended November 26, 2016.
