THE BUCKLE, INC. REPORTS NOVEMBER 2020 NET SALES

KEARNEY, NE -- The Buckle, Inc. (NYSE: BKE) announced today that comparable store net sales, for stores open at least one year, for the 4-week period ended November 28, 2020 increased 8.4 percent from comparable store net sales for the 4-week period ended November 30, 2019. Net sales for the 4-week fiscal month ended November 28, 2020 increased 8.1 percent to \$86.3 million from net sales of \$79.8 million for the prior year 4-week fiscal month ended November 30, 2019.

Comparable store net sales year-to-date for the 43-week period ended November 28, 2020 decreased 5.4 percent from comparable store net sales for the 43-week period ended November 30, 2019. Net sales for the 43-week fiscal period ended November 28, 2020 decreased 5.7 percent to \$668.8 million from net sales of \$709.1 million for the prior year 43-week fiscal period ended November 30, 2019.
